Certification Renewal: It is your responsibility to submit your Annual No Change Affidavit and most recent business taxes each year within the month that you were originally certified via the Civil Rights Compliance Reporting System at

These documents are to be submitted to DelDOT every year on the certification anniversary date and shall specifically state that the firm continues to meet business size criteria and the overall gross receipts cap. Any firm that fails to provide any of the aforementioned in a timely manner will be deemed to have failed to cooperate under §26.109(c) and is subject to immediate disqualification from the DBE Program. The DBE Program reserves the right to rescind certification if any information upon which it is based proves to be false, inaccurate, or misleading.
