Greetings,

Attached please find a 1-page list containing the names of
3 Newly Approved (non-gaming) Certified Vendors with our agency.

Please note the following seven (7) regulatory facts from our agency
regarding non-gaming Approved Vendors:

- 1) In Maryland, non-gaming vendors are never licensed – they are only eligible to achieve APPROVED vendor status.
- 2) Once a vendor is Approved at the initial casino they have contracted to conduct business with, that vendor is also approved to conduct business with ALL Maryland casinos.
- 3) Approved Vendors retain their status for five (5) years as long as they maintain their Good Standing status with MD SDAT.
- 4) The MD SDAT (Maryland State Department of Assessments and Taxation) Good Standing status requirement remains in effect for the 5-year duration of the Registration or Certification. Each Approved Vendor has a *continuing obligation* to the Maryland Lottery and Gaming Control Commission (MLGCC) to maintain their company's Good Standing status with MD SDAT. Please use this link to verify that your business continues to enjoy ongoing Good Standing status with MD SDAT:

- 5) Each Vendor Number (listed as a V, followed by 9 digits) is all that each business needs in the form of proof that it is now an Approved Vendor with our agency.
- 6) No "paper certificates" reflecting Approved Vendor status are ever issued by this office.
- 7) Sometime within the next week, our agency's Web Master will add the names of the Newly Approved Vendor

businesses to our agency's Web site page under the toolbar heading of "Approved Vendors":

According to COMAR (Code Of Maryland Regulations) 36.03.02.01.B.3-6 (regarding a vendor applicant's submission of a Vendor Form application and/or documents):

*"(5) An applicant notified in accordance with §B(4) of this regulation may submit the documents necessary to complete the application **not later than 15 days after issuance of the notification.***

*(6) The Commission **may not consider the application of an applicant** who is notified in accordance with §B(4) of this regulation, and **who fails to submit the requested documents in a timely manner.**"*

****NOTICE: Applicant Vendors who are not yet approved by the Maryland Lottery and Gaming Control Agency may not conduct, in any capacity prior to their approval, the provision of goods and/or services to any casino in the State of Maryland. If goods and/or services are provided prior to vendor approval, penalties and sanctions may be imposed by the Maryland Lottery and Gaming Commission, to include prohibition/denial of the Applicant Vendor.****
